Clause of Member's Disqualifications:

1. Any member of the scheme who does not pay his/her annual subscription and Fraternity Contribution as specified in Clause 7 (I) and (II) before 30th June, he shall pay Rs.50/- as Late Fee per month of default or part there of.
2. Ordinary notice for payment of Annual Membership Subscription and Fraternity Contribution shall be sent in April to be made before 30th June. After 30th June a notice by courier shall be sent for payment before 31st July with the late fees as prescribed. After 31st July, second reminder shall be sent for payment before 31st August with the late fees as prescribed. After 31st August a notice under Registered A/D shall be sent for payment before 30th September with late fee as prescribed.

If there is no response to the notices the Membership of the Member shall **AUTOMATICALLY** cease from 1st October and all amount standing in his / her name including balance of Fraternity Appropriation Fund shall be forfeited forthwith.
